AMENDMENT TO APPENDIX 2A

Silver Mines Limited (“Silver Mines” or the “Company”) (ASX:SVL) encloses an Appendix 2A (“Amended Appendix 2A”) to replace the Appendix 2A released by the Company on 13 September 2021 (“September Appendix 2A”).

The September Appendix 2A was released by the Company following the final exercise of SVLOB options expiring 6 September 2021 (“Final Exercise Date”) with an exercise price of \$0.06 (“SVLOB Options”).

Following the Final Exercise Date the share registry advised the Company that regrettably the Registry omitted to provide some exercise forms received for the valid exercise of SVLOB Options (“Additional SVLOB Holders”).

The Registry has informed the Company that the omission was caused due to staff working remotely due to COVID imposed restrictions. The Registry has conducted a full audit of its internal processes and all forms received in the lead up to the Final Exercise Date have been provided to the Company.

The Company confirms the enclosed Amended Appendix 2A now reflects the Additional SVLOB Holders who validly exercised their SVLOB Options. This results in an additional 544,776 fully paid ordinary shares being quoted.
